**S.R.O.NO.544/2005** .- The exercise of the power conferred by sub-section (1) and section of 5 of the Kerala Preservation of Trees Act, 1986 (35 of 1986); the Government of Kerala hereby direct that no tree standing in the area specified in the Schedule below shall be cut, uprooted, burnt or otherwise destroyed except on the ground that.-

- the tree constitutes a danger to life of property; or
- the tree is dead, diseased or wind-fallen:

### Explanatory Note

(The does not form part of the notification, but is intended to indicate its general purport)

The area specified in the schedule to the Notification comprised in forest Division, Nemmara and involved in O.A. 14/87 of Forest Tribunal, Palakkad, was portion of the vested forest. The lands, on restoration, are likely to be cleared by felling all the available trees, therein the guise of cultivation, which will adversely affect soil conservation and moisture retention in the area and cause soil erosion, destruction and loss of timber wealth in the State unless such clearing is prohibited. Therefore, it has been decided to bring the area specified in the schedule under the purview of section 5 of the Kerala Preservation of Trees Act, 1986.

The notification is intended to achieve the above object.
