1. STATE LEVEL COMMITTEE

The State Level Committee shall consist of-

- 2) Minister (Social Welfare) - Vice Chairman

- vii) Kerala Congress
- viii) Kerala Congress (Jacob)
- ix) Kerala Congress (B)
- x) Nationalist Congress Party
- xi) Janatha Dal (S)
- xii) Communist Marxist Party
- xiii) Janadhipathya Samrakshana Samithi
- xiv) Revolutionary Socialist Party (Bolshevik)
- xv) Revolutionary Socialist Party
- xvi) Janatha Dal (U)
- xvii) National Democratic Party
- xviii) People's Democratic Party

3. All Members of Parliament of the District
4. All MLAs of the District (If the MLA happens to be the Speaker or a Minister he may nominate a person to the District Level Committee)
5. The Superintendent of Police/city police commissioner
6. Three distinguished members from the public of the District to be nominated by the District Collector.

The Committee will meet whenever the Collector feels it necessary to convene it.

These Committees will also function as the Peace Committees.
