Sub:- Public Functions organized by State Government Departments / Public Sector Undertakings- Courtesies to be given to MLAs - Instructions issued- Regarding.

Ref:- Circular No.38454 / Pol.-1/ 2002 / GAD. Dated 18-5-2002.

In the circular cited above, instructions has been issued to the effect that in all public functions particularly those arranged under the auspices of government Departments/Public Undertakings in which Government servants participate it should be ensured that MLA/MP is accorded a due place of importance whether to preside over the function or to speak.

Government further wish to a clarify that if the public organized by State Government Departments/ Public Sector Undertakings pertains to more than one Assembly Constituency, then the MLAs representing all those constituencies shall be invariably invited to the function.

The above instruction has to be followed scrupulously.
