

**DIRECTORATE OF PROSECUTION, ERNAKULAM & O/O THE SPECIAL ATTORNEY  
KERALA LOK AYUKTHA, THIRUVANANTHAPURAM.**

Directorate of Prosecution was constituted/established as per G.O.(Ms)No.224/2000/ Home dated 13.10.2000. It started functioning headed by Director General of Prosecution to ensure effective control over the working of Assistant Public Prosecutors and to increase their accountability in the prosecution side in Magistrate Courts. The Administrative control which was entrusted with the District Collectors was later transferred to the Director General of Prosecution. The disciplinary actions against Assistant Public Prosecutors, their transfer and postings, appointments etc still rests with the Home Department. The Financial powers, appointment of provisional hands as Assistant Public Prosecutors are still remaining on District Collectors.

In addition to the establishment matters of Assistant Public Prosecutors, this office mainly deals with the files relating to withdrawal of prosecution, appointment of Special Public Prosecutors, Legal Opinion, Prosecution sanction etc which are forwarded by Government. Establishment matters of O/o the Special Attorney, Kerala Lok Ayuktha is also dealt within the Directorate of Prosecution.

The Director General of Prosecution is the Head and Controlling Officer of this Office. He gives guidance and directions to the Assistant Public Prosecutors. The Director General of Prosecution is entrusted with the duty of conducting inspection in the offices of Assistant Public Prosecutors in the State and also to enquire into the allegations/complaints against the Assistant Public Prosecutors. Director General of Prosecution is the controlling officer in respect of the head of account 2014-AJ-114-LAC-96-DPP. The Director General of Prosecution himself takes decision on all the files relating to Administrative/establishment matters as well as files having financial implications pertaining to this office

In addition to this the Director General of Prosecution has to attend various meetings convened by Government, Police Officers etc. Special Public Prosecutors are normally appointed by the Government after seeking opinion of the Director General of Prosecution.

Government have accorded sanction for the creation of 1 post of Director of Prosecution (Administration) in the Scale of Pay Rs.20700-26600) in the Directorate.

The duties and functions entrusted to the Director of Prosecution (Administration) are as follows:

**Administrative Powers:** Verification of Daily Work diaries and monthly statement submitted by the Deputy Director of Prosecution of the Districts and all Assistant Public Prosecutors in the State and the work of conducting enquiries on the allegations against the Deputy Directors of Prosecution and Assistant Public Prosecutors. Assessing the quality and quantity of the work rendered by the Deputy Directors of Prosecution and Assistant Public Prosecutors in the State. Inspection in the offices of Deputy Directors of Prosecution and Assistant Public Prosecutors as and when specifically instructed by the Director General of Prosecution when it is found necessary. Preparing legal opinion in various legal issues in the course of administration of Directorate of prosecution.

**Financial Powers:** Verification of expenditure statement and connected records, monitoring the monthly ceiling issued to the Deputy Directors of Prosecution of the State and examining of files relating to additional funds, re-appropriation, supervision of Budget preparation and examining files of financial implications relating to the head of account 2014-AJ 114-LAC 97-APPs strictly in accordance with the instructions from the Home Department. In addition to this transferring of certain duties and functions now being exercised by the D.G.P. to the Director of Prosecution ( Admn) is under consideration of the Government.

In addition, all files dealing with Administrative and financial matters to be seen by the Director General of Prosecution will be routed through the Director of Prosecution (Admn).

The Deputy Director of Prosecution of this office is designated as the Public Information Officer for disclosing the information sought under RTI Act as far as this Directorate is concerned.

Under Secretary is entrusted with general supervision of this Office. There are 15 employees working under various categories other than the officers mentioned above and Sr.Govt: Pleaders of office of the Special Attorney, Kerala Lok Ayukta, Thiruvananthapuram. Staff strength of Directorate of Prosecution and O/o the Special Attorney Kerala Lok Ayukta is also appended herewith for information.

The Senior Government Pleaders of O/o the Special Attorney, Kerala Lok Ayukta, Thiruvananthapuram are entrusted to carry out works assigned to them by the Special Attorney to represent before the Lok Ayukta and Upa Lok Ayuktas under the directions and guidance of the Special Attorney.

Work distribution among the ministerial staff of this office is as follows:

### Three Assistants:

**C Seat:** Establishment matters, Confidential Reports, Processing of Work Diaries etc. relating to Assistant Public Prosecutors of seven districts (Thiruvananthapuram, Kollam, Pathanamthitta, Alapuzha, Kottayam, Ernakulam and Idukki) are dealt with this seat. Budget and allied matters coming under the Head of Account 2014-114-97-APPs are also carried out in this seat.

**E Seat:** Files relating to withdrawal of Prosecution, Prosecution sanction and legal opinion are being done by this seat.

**K Seat:** Establishment matters and processing work diaries of Assistant Public Prosecutors of various northern districts, Thrissur, Palakkad, Malappuram, Kozhikode, Wynad, Kannur, Kasaragod etc.. Casual Leave Register of all Deputy Directors of Prosecution are processed in this seat.

**Lower Division Clerk:** All establishment matters relating to Directorate of Prosecution, Ernakulam and Office of the Special Attorney, Kerala Lok Ayukta, Thiruvananthapuram are dealt in this seat. Stationary and Printing, L.A. interpellations, Establishment Bills, T.A. Bills relating to the Directorate of Prosecution and Office of the Special Attorney, Kerala Lok Ayukta, Cash Book and accompanying Registers are also maintained by the Clerk.

One permanent post of C.A. which was reported to Kerala Public Service Commission has not been filled up till date. (The duty assigned to the former Confidential Assistant was to carry out Dictation work of the Director General of Prosecution, Arranging Inspection, Conference of Director General of Prosecution and Files relating to the appointment of Special Public Prosecutors.)

### Two Confidential Assistants

**F Seat:** Stenography and Typing work. (This temporary post is supposed to be abolished in future)

**G Seat:** Stenography and Typing work.

**Two Typists :** **H Seat:** Typing work. **J Seat:** One Typist is entrusted with additional duty of Tapal, Despatch, issuance of work diary Forms, , Maintenance of Periodicals and Books etc.

From Tapal to Despatch, procedures are followed as stipulated in the office manuals. All the communications received in the office after affixing current number and proper

entries in the Register, distributed to the Assistants/Clerks concerned. The Assistant after examination of the File, put up it with Notes and drafts and submitted to the Section Officer/Under Secretary, who in turn submit it before the Director of Prosecution (Admn) for further verification. The file verified will be placed before final orders. The Director General of Prosecution after verifying the content of draft and incorporating necessary changes will make final orders. The Director General of Prosecution is issuing orders in all cases relating to the Directorate of Prosecution, Ernakulam and Office of the Special Attorney, Kerala Lok Ayukta, Thiruvananthapuram..

This office discharges its functions based on the norms issued by the government from time to time.

Kerala Service Rules, Kerala State & Subordinate Service Rules, Office Manual and other circular instructions issued by the Government on various occasions are followed in this Office for discharging its functions.

There are 125 Assistant Public Prosecutors and 14 Deputy Directors of Prosecution in the State, in addition to the Director of Prosecution (Administration) and Deputy Director of Prosecution in the Directorate of Prosecution. The Director General of Prosecution have the administrative control over these officers.

Information relating to this office can be obtained from this office during working hours under Section b(1) of the RTI Act, 2005, on proper request.

As per order No.2379/D/05/DGP dated 29.12.2005 of this office, 14 Deputy Directors of Prosecution in the respective districts concerned were appointed as the Public Information Officers at District level and the Deputy Director of Prosecution and Under Secretary (then Section Officer), were designated as Public Information Officer and Assistant Public Information Officer respectively in the Directorate of Prosecution. The list of Public Information Officers at the District level and of this office is appended <sup>as on date</sup> separately for information. The Director General of Prosecution was designated as Appellate authority in the Directorate of Prosecution vide this office order No. 2379/D/05/DGP dated 21.8.2006. Smt.Mini.M.Nair, Senior Govt: Pleader and the Special Attorney to Kerala Lok Ayukta are the Public Information Officer and Appellate Authority respectively as far as the Office of the Special Attorney, Kerala Lok Ayukta, Thiruvananthapuram is concerned
