NOTIFICATION

G. O. (P) No. 135/2007/LBR. Dated, Thiruvananthapuram, 8th October, 2007.

S. R. O. No. 836/2007.—In exercise of the powers conferred by sub-section (5) of section 1 of the Employees' State Insurance Act, 1948 (Central Act 34 of 1948), the Government of Kerala in consultation with the Employees' State Insurance Corporation and with the approval of the Central Government, and after having given six months notice of its intention so to do, hereby extend the provisions of the said Act to the classes of establishments, specified in column (1) of the schedule annexed hereto and situated in the areas specified in column (2) thereof with immediate effect.

Educational institutions (including public, private, aided or partially aided) run by individuals, trustees, societies or other organizations, wherein 20 or more persons are employed or were employed on any day of the preceding twelve months. Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government in consultation with the Employees' State Insurance Corporation and with the approval of Central Government, have decided to extend the provisions of the Employees' State Insurance Act, 1948 under sub-section (5) of section 1 of the said Act to the Educational institutions (including public, private, aided or partially aided) run by individuals, trustees, societies or other organizations, wherein 20 or more persons are employed or were employed on any day of the preceding twelve months, in the areas where the scheme has already been brought into force under sub-sections (3) and (5) of section 1 of the said Act. A notification of the intention has already been published as per G. O. (P) No. 34/2007/LBR dated the 20th March, 2007 in the Kerala Gazette Extraordinary No. 600, dated the 26th March, 2007.

This notification is intended to achieve the above purpose.
