**ORDER**

As per the G.O read as first paper above, Government have approved the revised replanting project of the Rehabilitation Plantations Limited, Punalur and for the implementation of the project, Government have accorded sanction for the creation of a temporary post of Senior Manager (Plantations) on a pay scale of Rs. 14000-18000 for a period of three years vide G.O read as second paper above. The company had appointed Sri.K. Rajendranath to this post who had 25 years of service at various levels in the estate of the company who was also the senior most Manager. The tenure of the post of Senior Manager expired on 4-9-06 through the replanting project is to continue till 2018.

2. The Managing Director Rehabilitation Plantations Limited in this letter read as third paper above has reported to Government that for the successful continuance for the replanting activity, it is necessary to continue the post of Senior Manager (Plantations) considering the duties and responsibilities attached to that post. Hence it was suggested that the tenure of the post of Senior Manager (Plantations) be extended for a further period of three years so that about 60% of the area will get replanted by that time, The Board of Directors of the Company has also recommended for the continuation of the post.

3. Government have examined the matter. It is found that for the successful continuance for the replanting activity it is necessary to continue the post of Senior Manager (Plantations) at least up to the date of retirement of Sri. K. Rajendranath, who is holding the post of Senior Manager (Plantations) at present.

4. In the circumstances Government are pleased to accord sanction for the continuance of the post of Senior Manager (Plantations) in the Rehabilitation Plantations Limited, Punalur till the date of retirement on superannuation of Sri. K. Rajendranath who is holding the said post at present
