**ORDER**

The Secretary, State Planning Board, vide his letter read above has pointed out the need for the constitution of a steering committee to co-ordinate and scrutinize the projects prepared under SGSY by various development department.

Government of India sets apart funds every year under SGSY for project based funding to State Governments with a view to generating employment opportunities and increasing the income of the poor in the rural areas of the country.

On reviewing the projects, it has been brought out that only few projects are prepared and submitted to Government of India for getting assistance. As per the Annual Report 2004-05 of Government of India, Ministry of Rural Department, 168 numbers of projects have been funded and out of which Kerala received only 4 projects. When there is scope for implementing new projects in the State and Government of India is ready to make project based funding as many projects may be submitted to receive funds from Government of India to create employment opportunities and to increase the income of the rural poor in the State.

With a view to providing proper advice and guidance under SGSY, Government are pleased to constitute a steering committee consisting of the following members.
