S.R.O No./ 2002 - In exercise of the powers conferred by sub section (1) of Section 2 of the Kerala Public Services Act - 1968 (19 of 1968), read with Section 3 thereof, the Government of Kerala hereby make the following Rules further to amend the Kerala Service Rules, namely:-

**RULES**

(C.S.No. 10/2002)

1. Short title and commencement : (1) These Rules may be called the Kerala Service (Amendment) Rules, 2002.

(2) They shall be deemed to have come into force on the 5<sup>th</sup> day of September 1980.

2. Amendment of the Rule:- In Appendix II Part I of the Kerala Service Rules, for item 28 and the entries against it, the following item and entries shall be substituted, namely:

"28. Director of Municipal Administration"
