ORDER

The rank list for admission to Engineering Courses 2011 was prepared giving equal weightage to the marks obtained in the Engineering Entrance Examination and the marks obtained in the qualifying examination based on Prospectus for 2011 approved vide Government Order read as 5th paper above.

When the Engineering rank list 2011 was published on 10.07.2011, there was protests from a few quarters. The contention was that the students from Boards such as CBSE & ISCE have become the losers in the process of normalization.

The combined meeting of Reforms Committee and the Normalization Committee which met on 11.10.2011 for the review of activities and to discuss future course of action for 2012 has decided that the present mode of ranking followed in the Engineering Entrance Examination 2011 should continue. It was decided to constitute an Expert Committee for this purpose to study and suggest improvement, if required, in the present system. The Commissioner for Entrance Examinations was directed to submit a detailed proposal on this matter.

Vide letter read as 7th above, the Commissioner for Entrance Examinations has submitted a proposal for the constitution of an Expert Committee. Government have examined the matter and with a view to effectively streamline the preparation of Engineering Rank List 2012, Government are pleased to constitute an Expert Committee with the following members.
