## ORDER

Government sanctioned Khadi-Hindi Pension to 195 persons as per Government Orders read as 3rd, 6th, 8th and 9th papers above. Government have examined the applications of Smt.A.V.Narayani, W/o.Late Kizhakkeveettil Manan Kannan, Alavalappil House, Theru.P.O, Kunhimangalam, Kannur Dist and Sri.Vichicheri Padmanabhan, Vichicheri Veedu, Cherai.P.O. EDAT, Kannur Dist. in detail. In reference 11th cited the District Collector, Kannur has reported that Sri. Kizhakkeveettil Manan Kannan and Sri.Vichicheri Padmanabhan were involved in the popularization of Khadi and Hindi.

(2) In the reference 10th cited the Hon'ble High Court has directed the 2nd respondent, the District Collector, Kannur to consider the claim of the petitioner's afresh in the light of G.O(P)No.359/2004/GAD dated 20.12.2004 and G.O(P)No.17/2006/GAD dated 16.01.2006 and pass fresh orders on application dated 03.02.1995 submitted by Sri. Kizhakkeveettil Manan Kannan and application dated 22.03.1995 submitted by Sri.Vichicheri Padmanabhan. The court has also ordered to give a personal hearing to the petitioners. Accordingly a personal hearing was given to the petitioners by the District Collector, Kannur on 03.05.2012. Subsequently the Government and the District Collector, Kannur have reconsidered the matter with reference to the papers read as 5th and 6th above. Taking into consideration of the court directions and the provisions relating to Khadi-Hindi Pension Scheme the Government have decided to sanction Khadi-Hindi Pension to them.

- (3) In the circumstances, in continuation of the Government Orders read as 3rd, 6th, 8th and 9th papers above, Government are now pleased to sanction Khadi-Hindi Pension to Smt.A.V.Narayani, W/o.Late Kizhakkeveettil Manan Kannan, Alavalappil House, Theru.P.O, Kunhimangalam, Kannur Dist and Sri.Vichicheri Padmanabhan, Vichicheri Veedu, Cherai.P.O. EDAT, Kannur Dist. at the rate of Rs.2000/-(Rupees Two Thousand only) per month, specifying the same conditions stipulated in G.O read as 6th paper above with prospective effect. The District Collector, Kannur will issue the necessary proceedings sanctioning Khadi-Hindi Pension to Smt.A.V.Narayani, W/o.Late Kizhakkeveettil Manan Kannan and Sri. Vichicheri Padmanabhan from the date of the proceedings with prospective effect only.
- (4) The expenditure in this regard will be met from the Head of account "2235-60-107-99 -Kerala Freedom Fighters' Pension Scheme".
- The procedure will be similar in all respects to that being followed for disbursement of Kerala Freedom Fighters' Pension as specified in Government Order 6th paper above.
